Contest Dates: January 25 - March 16

## **Eligibility:**

# Timeline:

- January 25: Contest opens.

- March 17: Voting concludes, and winners are notified.

#### **Submission Guidelines:**

- Videos can be posted on Facebook, Instagram, or TikTok tagging Girl Scouts Spirit of Nebraska, and #ThinMintTwistDanceChallenge, or emailed to marketing@girlscoutsnebraska.org.
- All submissions must comply with copyright laws, including the use of royalty-free music approved by the contest organizers.
- By submitting a video, participants agree to allow Girl Scouts Spirit of Nebraska to use their content for promotional purposes.

### **Prizes:**

- Most Popular: Awarded to the video with the highest number of combined likes and shares on social media. Prize: Karaoke Machine.
- Most Entertaining: Recognizes the most creative, funny, or unexpected performance. Prize: \$50 in Girl Scout Program Credits.
- Best Solo Dancer: Awarded to the most outstanding individual performance. Prize: \$50 in Girl Scout Shop Credits.

### **Judging and Voting:**

• Social media likes and shares will count towards the "Most Popular" category.

- A committee selected by Girl Scouts of Nebraska will select winners for the other categories.
- Winning individual girl or troop will receive a single prize.
- All winners will be notified by March 17.
